Have first aid kit supplies in your work area been approved by a physician, indicating that they are adequate for a particular area or operation?				
Are means provided for quick drenching or flushing of the eyes and body in areas where corrosive liquids or materials are handled? Are eyewash stations and showers needed?				
If you have designated personnel to provide first aid, do you have a bloodborne pathogens program (CFR 1910.1030)?				
Are designated first aid providers trained in the potential hazards of bloodborne pathogens, and:
